#### **Description of the contest:**

- MyOris Pick the Winner Contest winners will be drawn from the group with the correct prediction, to be decided by the Oris panel of jurors.

#### **To Enter the contest:**

- Log in at [MyOris](#) Page. Select “Register” if not yet a member.
- Go to the contest Page, select one entry out of the 20 finalists.

## **Description of the voting and winner selection:**

The BaselWorld 2013 trip can only take place during BaselWorld, 25<sup>th</sup> April to 2<sup>nd</sup> May 2013 @ Messe Basel, Switzerland. Should the winner be unable to travel during these dates, Oris SA reserves the right to choose a new winner. The trip cannot be replaced with any other prize or cash of the same value.

Travel to and from the departure and arrival airports will NOT be organised by Oris SA.

The point of departure will be the nearest international airport to the registered address of the Facebook user when the draw takes place.

The prize does not include travel insurance: this is the responsibility of the person travelling.

Organisation of entry documents for Switzerland such as visas must be organised and paid for by the person travelling and is not the responsibility of Oris SA. Should an entry Visa be refused for any reason Oris SA reserves the right to choose another winner.

Oris shall have the right at any time to require proof of identity and/or eligibility of the entrant to participate in the contest. Failure to provide such proof will result in disqualification. All information, personal and otherwise, requested by and supplied to Oris for the purpose of the contest must be truthful, complete, and accurate. Oris may in its sole discretion disqualify any entrant should such an entrant provide untruthful, incomplete, or inaccurate information or by giving misleading personal details.

Oris is entitled, at its full discretion, to disqualify any participant who does not comply with any of these competition conditions. Should the winner be found in breach of these competition conditions before the prize has been delivered, Oris will cancel the delivery and proceed to a second draw. Application to the Competition implies the unconditional acceptance of the competition conditions.

There will be no neutral third party during the winner selection. The jurors' decision is final and no correspondence will be entered into.

The winner will be contacted only in accordance with the contact details provided at the time of registration.

Oris SA reserves the right to choose a new winner if i) the participant named as the winner fails to respond completely and truthfully to all necessary and requested actions (eg: acceptance of the prize, the provision of essential information) within seven (7) working days or any other time period to be stated by Oris, ii) if it is discovered after the fact that the entrant has provided incorrect or misleading information.
